# Woodland Management Plan

Following a public consultation from December 2017 to February 2018 a Woodland Management Plan has been approved for Stanmer Park and Estate.

This was confirmed by the Forestry Commission, the government department responsible for protecting, expanding and promoting the sustainable management of woodlands and increasing their value to society and the environment.

The WMP aims to:

- bring Stanmer's woodland back into active management
- maintain a balanced woodland ecosystem
- ensure that nature conservation, the landscape and historic environment are protected and enhanced

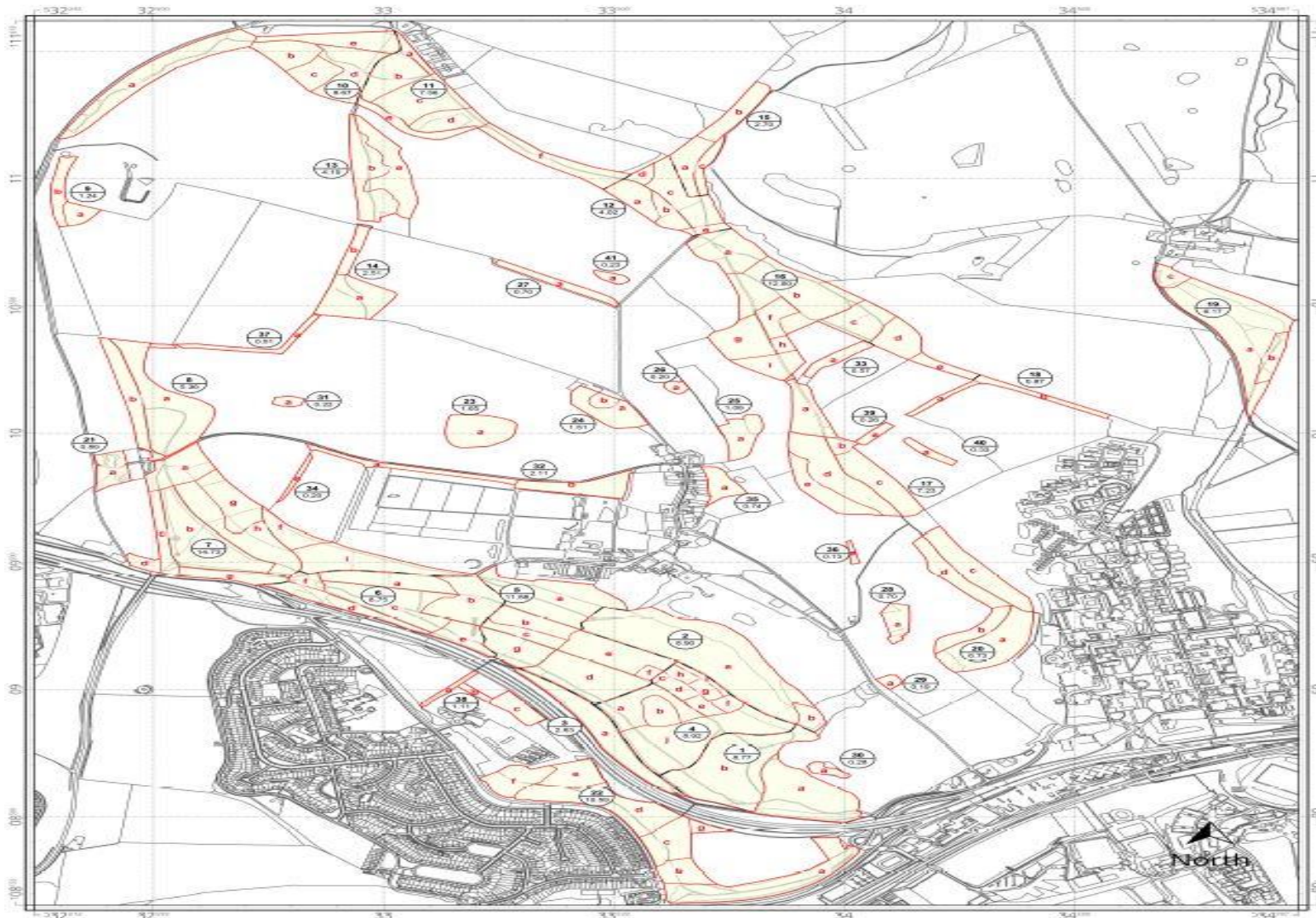
Activities resulting from the WMP will include:

- widening rides and key paths to diversify and create corridors for wildlife and add to park users' experience
- coppicing small areas to diversify the woodland structure
- thinning woodland to select for native and healthy trees
- ensuring adequate regeneration through natural means or re-planting

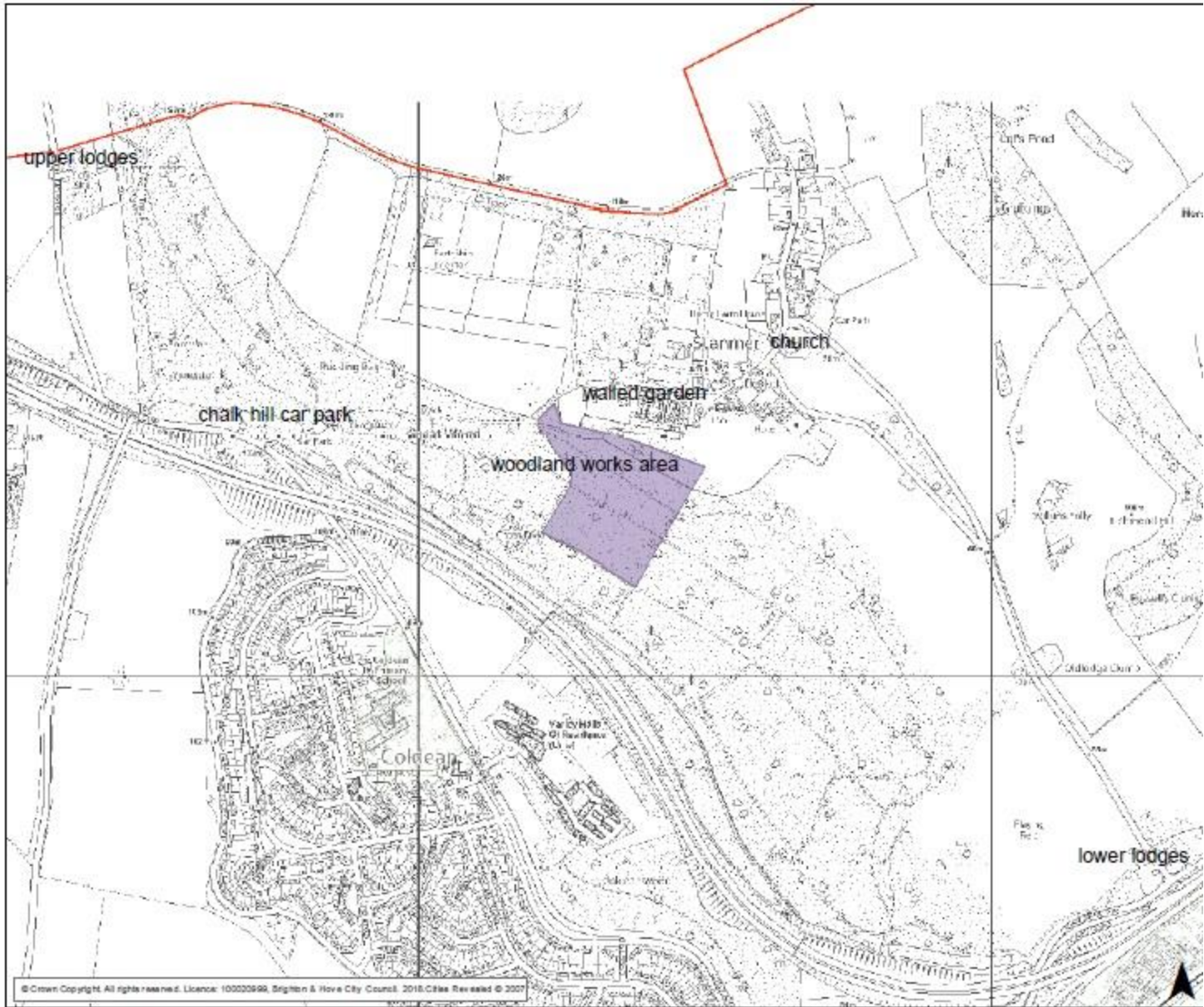
